

## **EUROMONEY INSTITUTIONAL INVESTOR PLC**

### **BOARD CHANGES**

Euromoney Institutional Investor PLC ("Euromoney") announces that Martin Morgan is to be appointed a non-executive director of the company with effect from today. Mr Morgan was previously chief executive officer of DMG Information, the business information division of Daily Mail and General Trust plc ("DMGT"), and also takes up his new role as Chief Executive of DMGT today.

Charles Sinclair retired from his role as a non-executive director of Euromoney with effect from September 30, 2008, coincident with his retirement from his role as Chief Executive of DMGT.

Also with effect from September 30, 2008, Peter Williams has stood down from his role as a non-executive director of Euromoney. From October 1, 2008 he will serve as an alternate director of Euromoney to Lord Rothermere. Mr Williams is Finance Director of DMGT.

The effect of these changes is to reduce the number of DMGT representatives on the Euromoney board from three to two. It is the company's intention to appoint a new independent non-executive director to the board in the coming months.

Commenting on these changes, Euromoney chairman Padraic Fallon said:

"Charles Sinclair has played a great part in the growth and development of the company, as has Peter Williams, who will continue to advise us and who will be an alternate director. We are immensely grateful to both of them. I welcome Martin Morgan to the board and look forward to working with him as we continue to develop the business. His experience of DMGT businesses like RMS, Trepp and Lewtan will be particularly helpful."
